### Closing the Avalon accounts of two long standing members

As explained below, the moderation team has unanimously decided to close the accounts of two long-standing Avalon members: Christine and Karelia.

We have deliberated on this for much of the last year, with our hearts as well as our heads. It has never been, nor is it now our desire to exhibit any ill-will. However, we can not stand by and consent with our silence. We desire neither to exacerbate the situation nor to exonerate misdeeds. We have taken a year to sort out our thoughts and feelings and create spaces for reflection and understanding.

During this time, an outpouring of Avalon Members and supporters shared with us privately their growing concerns regarding Christine and Karelia. In various off-forum dialogues, Christine and Karelia attempted to sow seeds of distrust against Avalon's founder Bill Ryan, the moderation team, and the general membership at large.

It has always been our hope that after a time, healing and forgiveness would take place, and emotions would calm down enough to move forward to a place of understanding and reason. It has also been our profound hope that Christine would make right her deliberate misdeeds, which include the embezzlement of Avalon Members Donations, and the outright theft of Bill's gold (the remnants of his inheritance). Unfortunately, none of these things have happened, and we are left with no choice but to take action.

It is also absolutely crucial at this time that we address the delicate subject of the health and safety of Milabs, abductees, ritualistic abuse victims, targeted individuals, and other such systematically abused victims.

**The Avalon Community WILL NOT be used as a place where such systematically abused victims are "harvested", or otherwise privately cajoled into experimentation with non-professional counseling or unproven healing modalities, or earmarked as targets to further exploit with private agendas great or small. The moderation team feels it is important to add that Project Avalon does not endorse unprofessional or inexperienced psychological counseling of such victims. We encourage members to report any conduct they feel is to the contrary.**

Good counselors save lives. Christine and Karelia appear to be talented, spirited individuals - however they are not trained counselors, nor are they qualified to declare themselves "healers" of what are some of the most psychologically complex and challenging abuse victims. These victims need (and deserve) highly-trained trauma/abuse-victim support. It is our hope that Christine and Karelia will take this into consideration as they tread forward on their path. It will not continue at Avalon!

There are many experienced, professionals available who have specific training in this field, and have been working with victims of such systemic abuse for 25+ years. We highly suggest that members take this into consideration when researching potential help. It is our hope that members will use discernment when joining in focus groups and if engaging, engage with caution when experimenting with various healing modalities.

Project Avalon supports dialog between people with many unusual experiences. In fact, we encourage dialog, and we embrace the love, support, and release that such support can provide. **In this sense, Project Avalon is a support group**, however, we encourage people to be responsible and discerning. We cannot support self-appointed healers - even in cases where the intention is honorable.

We learned much from Christine and Karelia in prior years, and we value the important contributions that they have given Avalon - including many valuable hours on the moderation team, for which we are extremely grateful. However, **with the unfortunate changes in this last year**, mutual trust and respect have been destroyed. It is time for us to move forward with heavy, but considerate, hearts.

**Note:** This action was made solely by the moderation team. Due to the personal connection, Bill Ryan neither initiated this moderator action, nor influenced our decision. We would also like to add that the moderation team felt it was important to mention the theft of Bill's inheritance. ### **The Public Accusations:**

themselves."

*To all who would inquire this is what I have to say: When a contract is made, both verbal and legal .... it is made to be honored. For myself a person is only as good as his word. There are dignified ways to withdraw from a contract, it takes courage and acceptance of ones own responsibility including errors. I don't think private affairs of this nature are anyone's business but the two who contracted. I offer again as I have since we parted to sit and come to equitable terms. My multiple offers have so far been ignored.*

*I do not participate in public trials nor honor trials behind closed doors. I have lost some of my dearest friends and this brings me great sadness though it is but a flicker in the light of eternity, we will all eventually meet again. With Love ~ All Ways.*

### **The "Theft":**

On my last day in Ecuador I spent several hours with BR, we were sitting on a sofa in a café when I told him with full consciousness of my decision and that I honor my word.

***Bill, I took half of our liquid assets to be held by me in TRUST and not utilized until such time as we reach a equitable decision on how to divide our belongings."***

I have not violated my word. At such time that we reach an equitable and honorable agreement we, the two who contracted (and only interested parties in this sorted affair) would have been able to put this behind us. But you Bill Ryan, you seem to have selective hearing and memory. Not my problem, I Know what I spoke, I Know my intent and I Know I am Honorable in it.

Theft? Really?

And his claim that I knew he would go to the police and have me arrested in the airport, really? Please! Blatant lie, he doesn't communicate in Spanish to begin with and secondly and most importantly the [assets] he covets are [not registered within] Ecuador. We would both have been detained and all the [assets] confiscated.

*"Bill, have you lost your mind? Believe it or not there are people out there who you have slandered that love you still and have tried to tell you during these past months that you were digging your own grave.*

### **The "Embezzlement":**

This is probably the most ridiculous [and serious] charge and the most unsubstantiated accusation of all, you are using screenshots that no doubt you solicited from members proving that I was stealing [PA] donations.

So let me ask you this, does an embezzler keep meticulous accounts and send them to the person, again legally married spouse who swore to support her, she is embezzling from? Paul, you purposely used that inflammatory word.

Libelous slander.

*"Bill, you let the misconceptions stand? Bill, look through your emails (hint February 2, 2015) and send your mods screenshots of the emails I sent you asking for an agreement on how to disperse the [PA] donations and let them know you choose to not address my amiable suggestions."*

During the tumultuous moments of our separation I was locked out from MY PAYPAL account twice, an account which is vital for me to maintain, [redacted information for the protection of my legally registered PayPay account (since 2009) and personal and business bank account] which you and I used to receive donations from PA members. I spoke with you and told you I was changing the password so that I could make sure the account stayed open. You had already lost your bank account and PayPal account, losing mine didn't seem like a good option. The second lock out was never explained to me by the PayPal supervisors and miraculously after three days I was able to get in again. Did you forget we spoke about this?

I investigated the legal impact of receiving undeclared donations and realized that I could be libel for your mishandling of this. I wrote you and suggested that 3 to 6 months might be considered enough time for you to set up an alternative PayPal. You replied asking me to give you more time. I could have disconnected PA from my PayPal any time but didn't want to leave **us** without any access to funds.

Since BR never made any indication that we could reach an agreement, neither written or verbal I later changed the notification email address to my [earthempaths@gmail](mailto:earthempaths@gmail.com). By this point I felt that BR was intractable in his stance and viewed me as his enemy.

It also should be noted that ALL PA funds went to my US bank account from early on in our relationship and that BR and myself used the funds to live from.

My *embezzlement* totals a few thousand dollars over a period from January 2015 to whenever Ilie Pandia, helped by [BR], hacked into the PayPal account and disconnected it from PA. PayPal notified me of this via email to the registered email address. **This is the way BR operated even though I offered to change over the account anytime. There are Skype chats and emails for your reference.**

Oh, did he [BR] tell you about the \$1000 USD I handed him in cash the day before I left? Because he had no cash and no way to receive money, does an embezzler do that? Did he tell you that without me being ethical and sending money to another partner who was able to give it to him in Ecuador he would have been penniless? Does he tell you I sent him another \$1000 donation without me touching a penny of it.

Does he tell you that I gave 100% of my energy to his life and the forum. Does he not think I deserve anything compensation? No, I guess he wanted me out on the street without a penny to my name. Sweet.

Did he show you all the Excel spread sheets and the downloaded PayPal PDFs I sent him? I don't know, do I? **You tried me behind closed doors, the epitome of an inquisition. Sanctimonious twitter, I had ample time to do what? Confess my sins before the overlords of the Project? I know a vipers den when I see one and I don't consent to further injury, get it guys? You are not my keepers nor arbitrators of justice. It took BR and his mob 14 months to invent and stage a case against Claudia and myself.**

Oh, lets interject Claudia in here – What is it she has done? You link her to me and my "thieving MILAB harvesting ways" without one single objective reason given. The overlords of the Project are doing what? Protecting whom?

## **The “MILAB and Trauma abuse soul harvester”:**

This “charge” is pure fiction and was most likely cobbled together by Bill Ryan ill-using his role of authority and savior by contacting people he knew I and Claudia had tried to help (NOT HEAL). The only “MILABS” we have had contact with were in the support group with Evie Lorgen and Laura Leon, two *professionals*, that [all of us] thought [agreed] was a good idea. [This group was publically advertised.] No coercion there. It is the one and only time I received any financial compensation, and it is none of your business anyway.

Protecting the downtrodden (what a demeaning term) of the forum? We haven't talked to or written anyone on the PA forum for many months, other again than friends who have contacted us and NOT FOR HEALING.

The only notoriety we got as healers came from BR himself in his own glorification tendencies was when he started the *Heal the World* thread. He is the one who promoted me [us], through videos on YouTube and PMs he received from those who sought his help, he sent them to me. Right, Rachel?

We gave our love and support freely to so many it is heart breaking to watch those who we supported in Love be turned against us. This is on your shoulders Bill Ryan.

When a True Lover of Life's Heart breaks open joy spills out and the tears wash away the sorrow and the Light shines ever brighter.



**LET IT BE KNOWN, as sovereign free Beings neither claudia nor myself, christine, fall under any jurisdiction other than Our Divine Law.**

**Archonic possession accusation:**

You have to be kidding, right? You are still propagating (closely aligned with the word propaganda) that I was put under a spell of John Lamb Lash?

All the partners and myself have maintained a good relationship and are in communication regularly. I feel a high moral obligation to those who invested their life savings in the *ideal of community* presented by BR and myself. They still have trust in me because I am ethical and have offered to help in what way they can. They are the ones that reminded me that at numerous RECORDED meetings in which Bill stated that everything he had was mine, in which he made some of his more grandiose gestures to prove his generosity.

**Defamation of my character and that of our partner MT:**

I have [received] many numerous emails which BR has sent out to everyone I know and others I don't know, those involved and not involved, trying to do damage to me and our partner MT (his auditor who gave him hours and hours of auditing sessions for free, totaling many thousands of dollars).

Now I need another hot shower.

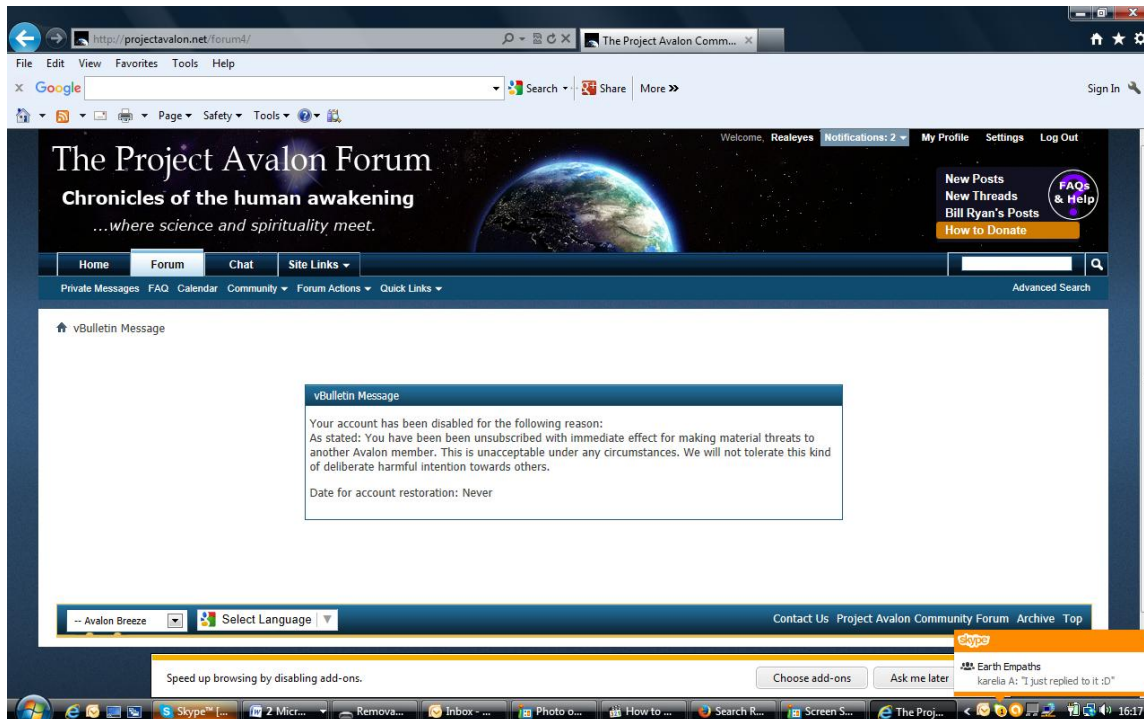
